## 2018 COMMERCIAL EXHIBITS CONTRACT

This contract does NOT guarantee an applicant a space. Vendor's contract will be reviewed and you will be notified if you are selected. Applicants are not guaranteed a space. **PLEASE NOTE: DUE TO THE REVISIONS TO SHOW FLOOR PLAN- WE ARE LIMITED TO 15 INDOOR BOOTHS & 16 OUTDOOR BOOTHS. THERE IS A MAXIMUM LIMIT OF 2 BOOTHS PER VENDOR ALLOWED- OUTDOOR BOOTH VENDORS WILL NEED TO BE SELF CONTAINED, PROVIDE THEIR OWN TENTS- MERCHANDISE SECURITY IS THE RESPONSIBILITY OF THE VENDOR. ALL FOOD VENDORS ARE OUTDOOR EXCEPT KITCHEN VENDOR.**

**ALL VENDORS MUST MAIL VENDOR CONTRACT PRIOR TO NOVEMBER 1, 2017 TO SHOW OFFICE ADDRESS. VENDORS MUST SUBMIT PAYMENT IN FULL AT THAT TIME. UPON ACCEPTANCE, VENDOR WILL BE NOTIFIED THAT THE PAYMENT WILL BE PROCESSED. IF VENDOR IS NOT ACCEPTED, THE PAYMENT WILL BE RETURNED IN FULL.**

The Association requires all vendors to obtain and show proof of liability insurance with a minimum coverage of \$1,000,000. (The Certificate of Insurance will need to show \$1,000,000 liability coverage, naming Kleberg Kenedy County Junior Livestock Association and City of Kingsville as additional insured covering the dates of the show.) OR Purchase the insurance coverage offered by KKJLS.

THE CERTIFICATE OF INSURANCE OR PAYMENT FOR KKJLS INSURANCE MUST BE RECEIVED PRIOR TO JANUARY 5, 2018.
