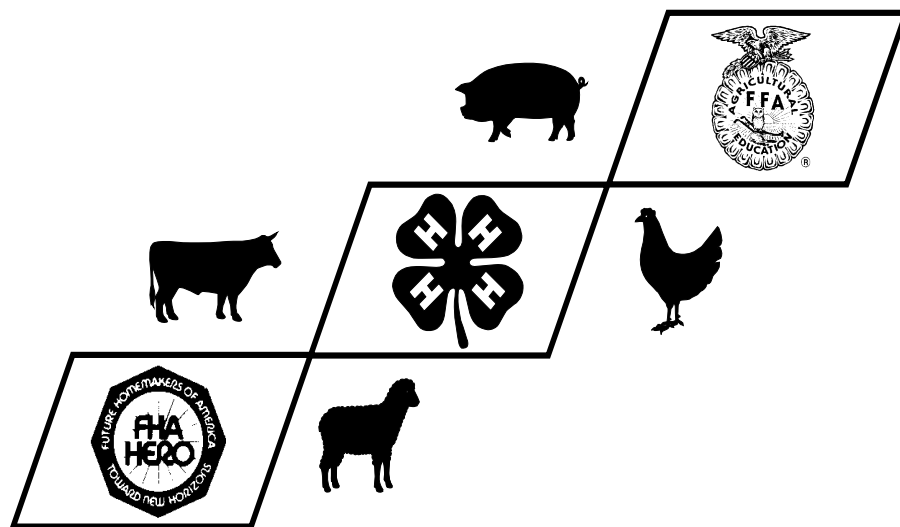

GENERAL SECTION

1. The Association Executive Committee for the Junior Livestock Show and Fair will consist of five members. Three of the members of the committee shall be members of the board of directors of the association and two of the members of the committee shall be members of the association that are elected by the membership at the annual meeting. The two members that are elected from the association membership shall not be board members. The Executive Committee shall have a General Chairman, A General Superintendent, and an Assistant General Superintendent whose positions are filled by board members that are elected by the membership at the annual meeting. The Executive Committee shall serve as the representative of the board of directors and its authority is limited to the duration of the annual livestock show. The "duration of the annual livestock show" shall be defined as: From the first scheduled event through the cleanup and disposition of the animals on Sunday after the sale.
2. The Association Executive Committee has the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters in regard hereto. An exhibitor who violates any of the following rules will forfeit all privileges, premiums, or ribbons. They are also subject to such punishment as the Executive Committee may order.
3. The Association Executive Committee has the final and absolute right to cancel the contract of the carnival and/or vendor(s) if they are found to be selling or giving away any drug or sexual related or objectionable items to any youth/minor of Kleberg or Kenedy Counties.
4. All protests must be in writing and be accompanied by cash, certified check or money order deposit of \$125 which will be forfeited if protest is not sustained. Such protest must state plainly the cause of complaint or appeal and must be delivered to the Livestock Show General Superintendent. Any protest not officially filed within 24 hours of the alleged incident will not be considered. These cases are referred to the Executive Committee which will have full power to act and from whose decision there can be no appeal. Judging procedures will not be interrupted for protest investigation. The General Chairman shall be in charge of protest hearing once convened. The General Superintendent shall receive the written protest and deposit from the protestor and request that the General Chairman convene a hearing to hear the protest. The General Superintendent shall also perform all of the duties of the General Chairman in the General Chairman's absence. The Assistant General Superintendent shall perform all of the duties of the General Superintendent in the General Superintendent's absence. A protest hearing must be convened within four hours from the time that the written protest and deposit were received by the General Superintendent unless extenuating circumstances prevent the hearing being convened within this time frame.
5. An Executive Committee member or Board member must recuse him or herself if a protest or any discussion that is brought forward involves a family member be it individual or committee member.
6. No one will be allowed to stay on the Show grounds overnight except the cook off participants (only during the cook-off events), carnival employees, and the night watchman hired by the Association. The coliseum and horse barn will be closed to all exhibitors and visitors at midnight on check-in day. For the remainder of the show, the buildings will be open from 5:00 a.m. to 10:30 p.m. The General Chairman may grant access to staff for auction set-up and other valid reasons. Livestock may not be fed, handled, or disturbed after closing time.
7. An official Livestock Show Photographer will be designated for two (2) year term by the Board of Directors. The Queen's Contest, Horse Show and Pee Wee Division Committees are responsible for securing a photographer for their respective divisions. The official show photographer will have exclusive rights to backdrop and ring pictures. All other photographers in violation will be asked to remain in bleachers while taking pictures.
8. Judges for the lambs, goats, cattle and swine divisions **MUST be selected on or before June 1st by Division Superintendent/Assistant Superintendents and approved on or before the June meeting by the board of directors. If no judge is presented by a livestock division for approval by that time, one will be selected by the Board of Directors. In the event original judge selected withdraws from obligation, the superintendent shall replace the judge with another judge and the board's approval.**
9. Judges for stock horse, poultry, rabbit, horse show and farm shop divisions **MUST be selected on or before August 1st by Division Superintendent/Assistant Superintendents and approved on or before the August meeting by the board of directors. If no judge is presented by a division for approval by that time, one will be selected by the Board of Directors. In the event original judge selected withdraws from obligation, the superintendent shall replace the judge with another judge and the board's approval.**
10. All rules and regulations pertaining to the show must be finalized on a date specified by the board approximately 90 days after the previous year's show. All proposed rule changes must be submitted, in writing, to the recording secretary within 60 days after the previous year's show. The Board will also meet within 30 days of the livestock show to go over Pros and Cons of the previous show.
11. Any balance owed to the Livestock Show Association from an exhibitor and/or exhibitor's parent or legal guardian will be deducted from the exhibitor's check or scholarship payment.
12. The Kleberg-Kenedy County Junior Livestock Show never has ownership of any project. Therefore, the Kleberg-Kenedy County Junior Livestock Show is not responsible for injuries, death or damages to any project.

13. Exhibitors names will be announced solely for results purposes and not prior to or during competition.
14. Check-in for all livestock and poultry divisions for the annual livestock show will be on Wednesday before the sale. Steers, Lambs, Goats and Swine will be allowed to stall their animals starting at 10:00 a.m. with official weights and check-in beginning at 3:00 pm and ending at 6:00 p.m. Horses, Rabbits, and Poultry entries will check-in beginning at 3:00 pm and end at 6:00 pm. All livestock trailers must be removed from the show grounds after check-in.
15. All entries must comply with the general Rules and Regulations as well as all division rules. Failure to comply with the rules will result in disqualification of entry.
16. The Association Show Office shall be identified as being in the custody of the Association's bookkeeper/administrative assistant. The current mailing address is P. O. Box 648, Kingsville, Texas 78364-0648.
17. Only the name of the exhibitor, club they are a member of, awards, and information pertaining to that livestock project or farm shop project may be displayed in the exhibitors area during livestock show.
18. Any concerns of any section of Rules, or complaint of any rule, or a complaint of exhibitor must do the following: 1) contact the superintendent of that division with your complaint, and in turn he/she will contact the President, 2) must have a written complaint or appeal within 24 hours of contacting superintendents, and 3) the Board will then take the matter under review and the person or persons will be contacted on the boards ruling.
29. Any exhibitor found not complying with the rules and regulations of the Kleberg Kenedy County Junior Livestock Show may not be allowed to show in any division he/she has entries in. No entry fees will be refunded to any exhibitor found in violation of show rules and regulations.
20. At least one board member shall attend and oversee each livestock show event to ensure the rules are followed.

ELIGIBILITY SECTION

1. With the exception of the Adult Homemaking Division, Livestock Judging, and the Cook-Off, only bona fide FFA, FCCLA, and 4-H members of Kleberg and Kenedy Counties are eligible to show and sell in the Kleberg-Kenedy County Junior Livestock Show and must be attending Elementary, Jr. High, or High School in Kleberg or Kenedy County or must reside in Kleberg or Kenedy County while attending an Elementary, Jr. High, or High School outside of Kleberg-Kenedy county. Eligibility is monitored by County Extension Agent 4-H Youth Development and/or FFA/FCCLA Supervisor. A list of eligible students will be given to division superintendents. Non-eligible students will be notified by their organization supervisor.
2. All exhibitors will be under the supervision of the General Superintendent, but the organization will in no case be responsible for any loss or damage that may occur to animals, projects or persons.
3. All exhibitors must be neat, clean, appropriately dressed, and well groomed. Good grooming for boys shall include a haircut which ensures no hair hanging over a dress shirt collar, in the face, or below the middle of the ear. Side burns must be kept neatly trimmed and not extend below the ear. Beards and mustaches are not allowed. Boys are expected to shave as often as the situation dictates in order to maintain good grooming habits. Good grooming for the girls shall include a modest hair style which does not cover the eyes. These guidelines will be used by the division superintendents which will approve all exhibitors before their entries are accepted. The guidelines are to be followed during the entire show. Failure to comply with this rule will result in the exhibitor not being allowed to participate in the show.
4. Exhibitors in the show must not use or have in their possession any tobacco products, drugs, or alcohol.

ENTRY SECTION

1. Application for entry: All Entries shall be submitted online by November 1st by the exhibitor or parent/guardian along with entry fee. Incomplete entries will be disqualified. Fees are non-refundable or transferable. Late entries will be allowed but must submitted online before December 23rd and will be charged a late fee as shown in Entry Fee Schedule in addition to the regular fee. There will be no late entries accepted after December 23rd. The name of the exhibitor will not be in the catalog if the November 1st deadline is not met. In all cases, the right is reserved to reject or accept conditionally any application for entry. (Exceptions to these dates are Livestock Judging, Cook Off and Poultry Orders as these divisions have entry deadlines different in the division rules).
2. Acceptance of the Certification statement within the online entry process, regarding proper withdrawal time of drugs, chemical, or feed additive equates agreement by the exhibitor and their parent/guardian. All sale monies shall be held until drug tests are completed and monies will be returned to the buyer of any animal that has been condemned by the USDA and/or FDA.
3. The showing of any animal that has been administered any quantity of diuretic, unapproved growth stimulant or other unapproved medication, or that has not been properly withdrawn from approved drugs is prohibited. The showing of unethically fitted livestock is prohibited. Unethical fitting means any attempt to alter the natural appearance, conformation or weight of an animal by any unnatural means. Penalties for improper use of medications or unethically fitted livestock will be prescribed by the Kleberg-Kenedy County Junior Livestock Show Board of Directors or the Executive Committee based on the severity of the

violation. Any market animal that requires medication with a withdrawal period to be administered on the show grounds will be ineligible and removed by the exhibitor from the grounds.

4. The entry forms must have the exhibitor's valid name and social security number (SSN) or Individual Tax ID Number (ITIN) which can be validated by the association with the Social Security Administration or the IRS. Validation will be completed prior to the entry check in date for all projects that could potentially sale at the show. If validation of the name and SSN is not able to be accomplished prior to check-in, the project will NOT be allowed to check-in to the show.
5. An exhibitor will NOT be allowed to check in their project if they or a member of their immediate family has an outstanding balance due to the association.
6. All Exhibitors **with the exception of PeeWee and Adult Divisions** must be Quality Counts certified through their respective Texas 4-H or FFA program by entry deadline. Exhibitor's Quality Counts certification number is required at time of online entry. Failure to comply with this rule will result in disqualification. Quality Counts certification numbers will be verified through Texas Agrilife Extension Office and/or FFA advisors.

Entry fees are due with entry. Fees are non-refundable.

Entry fees are due with entry and credit card payments will be implemented with online entries. A Service Fee of \$5.00 will be charged to each Exhibitor.

VALIDATION SECTION

1. The validation process may include but not limited to ear tags, tattoos, nose print, photographs, DNA sampling, or other means as determined by the Board of Directors. The Grand Champion and Reserve Grand Champion of each division, and at least one other sale animal randomly selected from each division may have their validation confirmed before premium monies are paid.
2. ALL Market and Pee Wee animal projects that are required to be validated MUST be validated on the date or dates AND at the time or times AND at the location or locations as determined, voted on and set by the Board of Directors. Failure to meet these requirements will result in no animal being validated under any circumstances.
3. ALL Market and Pee Wee animal projects that are required to be validated MUST be present at the validation on the date or dates AND at the time or times AND at the location or locations as determined, voted on and set by the Board of Directors. Failure to meet these requirements will result in no animal being validated under any circumstances.

4. There is no limit to the number of Market animals that may be validated in each division or divisions. There MUST be at least one (1) Market animal of a division validated for each immediate member of a family if validation is done for animals that may be showed by other immediate family members. Each immediate family member MUST have an entry and an animal for each division.
5. A validation fee of five dollars (\$5.00) will be assessed to every Market Steer, Swine, Goat and Lamb that an exhibitor has validated. A validation fee of three dollars (\$3.00) will be assessed to every rabbit validated on the 1st validation. This validation includes breeder rabbits and bred does for the purpose of kindling the market rabbits and fryers. The validation fee will be collected at the time of validation. The validation fee will be waived if the Market animal has been validated with a State or Major Validation Tag.
 - A. All breeding cattle MUST be present at steer validation on date or dates AND time or times AND location or locations as determined, voted on and set by the Board of Directors, to verify possession or ownership. The Beef Superintendent will require a copy of the registration papers to be filed at the show office on registered animals. Non-registered animals will be ear tagged.

BEEF SUB-SECTION

- A. All steers are to be owned and in possession of the exhibitor as of validation date.
- B. All exhibitor names and validation information will be recorded at validation.

STOCK HORSE SUB-SECTION

- A. All horses will be validated on date or dates set by the board.
- B. All exhibitors names and validation information including photos will be recorded at validation.

LAMB SUB-SECTION

- A. All lambs are to be owned and in possession of the exhibitor as of validation date.
- B. All exhibitor names and validation information will be recorded at validation.

SWINE SUB-SECTION

- A. All swine are to be owned and in possession of the exhibitor as of validation date.
- B. All exhibitor names and validation information will be recorded at validation.

POULTRY SUB-SECTION

- A. All broilers will be validated at the time of pick up.
- B. All exhibitor names and validation information will be recorded at time of pick up.

RABBIT SUB-SECTION

- A. All breeder rabbits (bucks and does) to be exhibited at the show as a breeder rabbit must be validated on date or dates set by the board. In addition, any doe bred for the purpose of kindling the market rabbits and fryers must also be validated on date or dates set by the board. Two superintendents/assistants will be present at any and all validation procedures.
- B. Meat pens will be validated at a central location or other locations as deemed appropriate by the Superintendent on date specified by board.

GOAT SUB-SECTION

- A. All goats will be validated on the date or dates set by the board.
- B. All exhibitor names and validation information will be recorded at validation.

6. State or Major Validation tags applied on or before the last Kleberg Kenedy County Junior Livestock Show (KKCJLS) County Validation date for that specie will be honored as proof of possession and will serve as the validation tag for the KKCJLS and those animals will not be required to attend the KKCJLS validation date. Exhibitors moving to Kleberg or Kenedy County before the entry deadline must present proof of State Validation transfer into Kleberg Kenedy County and provide a notarized letter from their previous FFA Advisor or County Extension Agent stating and proving that the animal being transferred to Kleberg/Kenedy County has not been shown in another county show. In addition, the notarized letter from the previous Agriculture Science Teacher or County Extension Agent should include the date of state validation. Transfer animals that were validated in the state validation program of another county on a date later than the last KKCJLS validation date for that specie, those shown in another county show, or those not able to prove transfer of state validation to Kleberg or Kenedy County are ineligible for entry in the KKCJLS.

LIVESTOCK & POULTRY GENERAL SECTION

1. All animal entries must comply with the Texas Animal Health Commission rules. These rules may be obtained through the Texas Animal Health Commission. All animals, excluding broilers, will be weighed using a certified scale.
2. All Livestock and poultry must be in possession of and under the daily care of the exhibitor and kept in Kleberg/Kenedy Counties after validation requirements. If an exhibitor takes the project out of the county for any reason during the feeding period, the project must remain in the care of the exhibitor or immediate family members

- possession. A limited list of some examples of out of town needs are as follows: a) Veterinary care, b) hoof trimming, c) prospect shows, and d) education clinics.
3. All animals and poultry will be passed on by the sifting judge. Animals must be healthy, of show quality and condition. Animals showing signs of sickness may be sifted on the recommendation of a veterinarian. All sifted animals must be removed from the show grounds immediately by the exhibitor, or the association will contract removal at the exhibitor's expense. The exhibitor will be ineligible to participate in KKJLS for a period of one (1) year.
 4. The General Superintendent or Division Superintendent will make stall or pen assignments.
 5. All livestock, poultry, and rabbit exhibits must be in their assigned stall or pen and ready for exhibit at the end of check-in.
 6. Each exhibitor must furnish feed and care for their exhibit. All exhibitors are expected to keep pens/stalls clean. Failure to do so may cause money to be forfeited and removal of animals from the show. Inhumane treatment of livestock and poultry will be appropriately treated by show official up to and including being banned from future shows.
 7. All exhibitors must be present in person with their livestock or poultry projects for the weigh-in, (animals will be weighed one time only with scale monitor in clear view of exhibitor, parent, and Division Superintendent) sifting, judging, sale order, sale, and any other time their livestock or poultry projects are called for during the show except when excused by the General Show Superintendent. Any exhibitor not present when called to show may not be allowed into the ring. Excluding poultry and "legally" handicapped exhibitors, only exhibitors and their projects will be allowed in the holding pens and the show ring. The Executive Committee, after hearing the reason that an exhibitor is unable to show their project, may grant an exemption from showing their project if sufficient facts show that the exhibitor has had a death of an immediate family member or the exhibitor has medical reasons by evidence of a doctor's note why they are NOT able to attend the show.
 8. Removal of Exhibits: No animal or articles on exhibit may be removed from the grounds without a special permit from the General Superintendent. All animals must remain in place until released by the General Superintendent. Violation of the rule will cause forfeiture of all premiums earned by the exhibitor.
 9. Any animal which becomes unruly and appears to be jeopardizing the safety of exhibitors will be removed from the ring or tied to the fence at the discretion of the superintendent of that division.
 10. Any device or appliance used for clipping, blow drying, cooking, lighting, etc. outside the main coliseum building must be a GFI protected circuit. All clipping and blow drying will be restricted to designated areas decided by show officials. Absolutely no extension cords will be allowed to stretch across any roads or wash racks. Trim tables, trim chutes, head rails, blowers, and clippers must be used in designated areas only.
 11. The livestock judging superintendent or assistants may use any livestock project that has been exhibited in the show (with the exception of Grand or Reserve Grand or any animal with a state validation tag) for the contest. The exhibitors agree to this upon entering their project in the show.
 12. The decision of the judges will be final in all cases, except where mistakes, fraud, misrepresentation, or collusion not discovered at the time of the award is proved. In such case, the General Superintendent, or such referee as he may appoint, may make decision, or the case may be referred to the Executive Committee, from whose decision there can be no appeal.
 13. All Division Superintendents will forward a list with the placing order to the General Superintendent immediately after their particular division has been judged. All supporting documents for the placing of the division shall not be allowed to leave the location in which the judging has taken place until turned over to the General Superintendent.
 14. All entries must merit the premium awarded.

POULTRY DIVISION

1. Premiums: Ribbons for First through Tenth Place: Grand Champion and Reserve Champion Pen of Commercial Broilers.
2. Classes: There will be one class of commercial broilers.
3. All broilers for the county show will be ordered by the poultry superintendent each year at the appropriate time and only these same broilers will be allowed to be entered in the County Show. All broilers shall originate from a hatchery free of pullorum disease and fowl typhoid or have a negative pullorum-typhoid test within 90 days before exhibition in order to comply with the Texas Pullorum and Fowl Typhoid Control Act of 1977. All broilers will be banded with a number band and the numbers will be issued to the exhibitor at the time that the broilers are picked up. The bands must remain on the broilers and the exhibitor must present their number banded broilers at check-in and for the show or the entry will be disqualified. Any signs of tampering will disqualify the entry. Broilers without uniquely numbered bands will be disqualified. Family pens will be allowed if the exhibitors are siblings or step siblings. Other family relationships will not be allowed. Birds shall be ordered during entry process.
4. All broilers must be owned and in possession of the exhibitor at least 5 weeks prior to the show.
5. Each exhibitor may enter only one pen of broilers. A pen shall consist of three birds.

6. Each exhibitor may present only three birds for sifting. The sifting judge may allow a substitute to be presented if one of the three birds is damaged.
7. All birds must be clean and free of external parasites or be sifted.
8. Diseased birds will be barred from the show.
9. Exhibitors must place their name and organization on the box or cage that is used to transport their broilers to show.
10. At the discretion of the judge, birds must be "show quality" or they will be sifted.
11. Upon completion of Poultry Division judging and sale order placement, exhibitors will be required to remove two broilers from the show barn, leaving one (1) broiler for display in the show barn. The exhibitor is responsible for removing the two extra broilers from the Show Grounds. Exhibitors will be allowed ONLY one (1) broiler on the Show Grounds after judging and sale order placement is complete.

MARKET LAMB DIVISION

1. Each exhibitor may enter one ewe or wether lamb.
2. There will be five breed classes. The classes will be Dorper, Southdown, Finewool, Finewool Cross, and Medium Wool. Lambs will be classified as to breed class by the sifter/classifier at check-in. The decision of the sifter/classifier is final and not subject to protest.
3. There will be a minimum weight of 90 pounds except Dorpers and Southdowns, and their minimum weight will be 80 pounds. Lambs must have no permanent incisors in view, at time of check-in. Lambs will be weighed one time only.
4. Lambs must be shorn slick to ½ of an inch or less of the skin above knee and hock joints before arrival on the show grounds. The wool can not be longer on any part of the body and head than any other part, except on Southdowns and Finewools, wool may be left around the ears and topnotch of these breeds. Shearing will be allowed outside the coliseum.
5. Lambs will be broken into weight classes at the discretion of the division superintendent.
6. No painting, powdering, or artificial coloring is allowed.
7. The top ten Lambs in each class will be placed and awarded ribbons.
8. The show will award \$100.00 to the exhibitor of the Grand Champion lamb and \$50.00 to the exhibitor of the Reserve Champion lamb if those lambs were bred and originated from flocks in Kleberg-Kenedy Counties. Breeders of the Grand and Reserve Champion lamb will be awarded a plaque if those lambs were bred and originated from herds in Kleberg or Kenedy Counties.

MARKET GOAT DIVISION

1. The exhibitor can enter only one market goat.
2. Goats may be any breed or cross breed, wether or doe.
3. Goats will be divided into weight classes at the discretion of the division superintendents and assistants.
4. Any goat which weighs under 50 pounds will be sifted. Goats will be weighed one time only.
5. All goats must be dehorned with the exception of a doe prior to arrival of check-in.
6. Goats must be shorn slick to ½ of an inch or less of the skin above knee and hock joints before arrival on the show grounds. Shearing will only be allowed outside the coliseum.
7. Water buckets will not be allowed in exhibitor's pen unattended.
8. The show will award \$100 to the exhibitor of the Grand Champion Market Goat and \$50 to the exhibitor of the Reserve Champion Market Goat if those goats were bred and originated from herds in Kleberg-Kenedy.
9. All goats are to have a county or state validation tag at time of check-in. All other tags are to be removed prior to check-in except USDA scrapie identification tag.
10. The Goat Division will award a Division Champion and Reserve Division Champion for Lightweight, Middle Weight and Heavy Weight Division.

PEE WEE GOAT SHOW

1. The Pee Wee Goat Show is open to Kleberg-Kenedy County youth ages 4-8 (who are ineligible to participate in 4-H or FFA because of age or grade level). All exhibitors should attend a supervised educational workshop and must be a member of 4H or Pre 4-H and/or FFA or Pre-FFA group.
2. Goats may be any breed or crossbreed, wethers or kid doe. Goats must be carrying all milk teeth, in good general health at time of validation.
3. At county validation all tags must be removed with the exception of USDA scrapie identification tag and will be replaced with a County tag. This may be an immediate family validation. However, each exhibitor involved must have an entry in the Pee Wee Goat division.
4. Validation will be held on the 2nd Saturday of December, time and location to be announced.
5. On show day goats must be in good general health. The show will begin as quickly after check-in as possible.
6. Pee Wee will be Showmanship Classes only.

7. An award will be given to a Grand and Reserve Junior and Senior Showman. Junior ages are 4-5 years of age; Senior ages are 6-8 years of age. Each exhibitor will receive a blue ribbon. Exhibitors will be judged on showmanship skills only.
8. All goats will be released at the conclusion of the show.
9. Pee Wee Junior ages are 4-5 of age; Pee Wee Senior ages are 6-8 years of age. Age of exhibitor will be their age at day of all Pee Wee Goat Division shows.

SWINE DIVISION

1. Hogs will be divided into 5 breeds.
 - A. Crossbreeds - sire and dam are of different breeds
 - B. Durocs
 - C. Hampshires
 - D. Yorkshires
 - E. O.P.B. - all other pure breeds

Hogs will be broken into weight classes at the discretion of the division superintendent.
2. Each exhibitor can enter only one market hog.
3. Either barrows or gilts may be shown.
4. Sifting and classifying will be done at weigh-in. The decision of the classifier as to breed class is final and not subject to protest.
 - A. All hogs must grade US No. 1 or 2 and be of show quality or will be sifted.
 - B. All hogs must weigh 230 pounds to 275 pounds or will be sifted. The Swine Superintendent will allow 3 pounds over or under the established weights to compensate for scale variances.
 - C. All hogs must be free of parasites or will be sifted.
 - D. All hogs will be weighed one time only. No reweighs will be allowed.
 - E. All hogs must be washed and clean before weighing or will be sifted.
5. First place hogs in each breed weight class will compete for Breed Champion. The 2nd place winner in the class which produced the Breed Champion will compete with the remaining 1st place hogs of that breed for Reserve Breed Champion. The 5 Breed Champions will compete for Grand Champion. The Reserve Breed Champion from the breed that furnishes the Grand Champion will compete with the remaining Breed Champions for Reserve Grand Champion hog.
6. All hogs in each class will be placed and awarded ribbons.
7. The show will award \$100.00 to the exhibitor of the Grand Champion hog and \$50.00 to the exhibitor of the Reserve Champion hog if those hogs were farrowed in Kleberg-Kenedy Counties. Breeders of the Grand and Reserve Champion Hog will be awarded a plaque if those hogs were bred and originated from herds in Kleberg or Kenedy Counties.

PEE WEE PIG SHOW

1. The Pee Wee Pig Show is open to Kleberg-Kenedy County youth ages 4-8 (who are ineligible to participate in 4-H or FFA because of age or grade level). All exhibitors should attend a supervised educational workshop and must be a member of 4H or Pre 4-H and/or FFA or Pre-FFA group.
2. Hogs may be any breed or crossbreed, gilts, barrows, boars allowed.
3. Validation date and location will be announced at the November meeting.
4. On show day hogs must be in good general health and should weigh no more than 150 lbs.
5. An award will be given to a Grand and Reserve Junior and Senior Showman. Junior ages are 4-5 years of age; Senior ages are 6-8 years of age. Each exhibitor will receive a blue ribbon.
6. All hogs will be released at the conclusion of the show.
7. Exhibitors will be judged on showmanship skills and condition of project.

RABBIT DIVISION MARKET RABBITS

1. Exhibitors will kindle their market pen entries.
2. Rabbit market pens will be divided into the following breeds (and varieties):
 - A. New Zeland - all American Rabbit Breeding Association (ARBA) approved varieties.
 - B. Californian
 - C. Other ARBA Commercial Type body profile rabbits (meat rabbits).

Meat pens shall consist of three rabbits, all of the same breed and variety.

3. Exhibitors may breed their own does or purchase bred does. All does must be the bona fide property of the exhibitor prior to the validation date of the doe. The target breeding date is 100 days prior to the show with an ideal kindling date of 70 days prior to the show.
4. Each exhibitor is limited to one pen. Participants failing to successfully kindle 3 fryers may exhibit 1 or 2.
5. Meat pen entries eligible for the sale shall consist of 3 purebred rabbits of same breed and (variety) each fryer male or female shall weigh 3.5-5.5 pounds with -0.04 on the bottom end only. Age limit is 10 weeks. Rabbits will be weighed one time only.
6. At the time of weigh-in, all rabbits will be sifted by the Sifting Judge as per current ARBA (American Rabbit Breeders Association) standards. The rules are listed in the ARBA Standards of Perfection booklet under "General Faults", "Disqualifications from Competition", and "Standard & Guide for Judging Meat Classes". Any sifted market pen must be removed from the facilities immediately.
7. The top ten pens of each breed class will be placed and receive an award. Blue and red ribbons will be awarded at the discretion of the judge. Grand Champion and Reserve Grand Champion pens will receive an award.
8. Sale order for market rabbit pens will be determined by class place. 1st place pens in each class will be judged to determine the Grand Champion pen, the 2nd place pen in that class will be judged against the remaining 1st place pens, etc., until all pens have been placed.
9. The market pens will be judged according to the following four factors, in order of their importance: (1) Meat type, (2) Condition, (3) Uniformity, (4) Fur; as outlined in the current *Standards of Perfection* booklet published by the ARBA.
10. The show will award \$100.00 to the exhibitor of the Grand Champion market rabbit and \$50.00 to the exhibitor of the Reserve Champion market rabbit if those rabbits were bred and originated from rabbits in Kleberg-Kenedy Counties. Breeders of the Grand and Reserve Champion market rabbit will be awarded a plaque if those market rabbits were bred and originated from herds in Kleberg or Kenedy Counties.
11. By the third day after each doe has kindled her kits, the Superintendent or designee must be notified. There will only be one person assigned to receive the notifications. This person's name, phone number and email address will be listed on the doe validation form. The superintendent/assistant superintendent will visit to inspect the kits within three weeks. Upon inspection of the kits, the tattoo of the doe that kindled the market rabbits will be cross-referenced against the doe validation form to ensure the doe has been validated.
12. The Superintendents can tattoo during a spot check at their discretion.
13. Market Rabbits do not participate in the resale process. Therefore, exhibitors must remove all rabbits from the show barn at the conclusion of the livestock show sale. Any rabbits remaining in the cages the morning after the completion of the show will result in the exhibitor being fined \$50.00.

SINGLE FRYER

1. Exhibitors will kindle their single fryer entry.
2. Single fryers will be divided into the following breeds (and varieties). All American Rabbit Breeders Association (ARBA) approved varieties.
 - A. New Zealand
 - B. Californian
 - C. Other ARBA commercial type body profile rabbits (meat rabbits)
3. Exhibitors may breed their own does or purchase bred does. All does must be the bona fide property of the exhibitor prior to the validation date of the doe. The target breeding date is 100 days prior to the show with an ideal kindling date of 70 days prior to the show.
4. Exhibitor is limited to one single fryer pen, **but must not be part of your market pen of 3.**
5. Each single fryer male or female shall weigh 3.5-5.5 pounds with -0.04 on the bottom end only. Age limit is 10 weeks. Fryers will be weighed one time only.
6. At the time of weigh-in fryers will be sifted by the Sifting Judge as per current ARBA (American Rabbit Breeders Association) standards. The rules listed in the ARBA standards of Perfection booklet under "General Faults", "Disqualifications from Competition," and "Standard and Guide for judging meat classes." Any sifted fryer must be removed from the facilities immediately.
7. The top 10 pens of each class will be placed and receive an award. Grand Champion and Reserve Grand Champion pens will receive an award. 1st place pens in each class will be judged to determine the Grand Champion, the 2nd place pen in that class will be judged against the remaining 1st place pen **for Reserve Champion.**
8. The fryer will be judged according to the following factors, in order of their importance: (1) meat type, (2) condition, (3) fur; as outlined in the Current Standards of Perfection booklet published by the ARBA.
9. The show will award \$30 to the exhibitor of the Grand Champion fryer and \$20 to the exhibitor of the Reserve Champion Fryer, if those rabbits were bred and originated from rabbits in Kleberg-Kenedy Counties
10. By the 3rd day after each doe has kindled her kits, the Superintendent or designee must be notified. There will only be one person assigned to receive the notifications. This person's name, phone number and email address will be listed on the doe validation form. The Superintendent/ Assistant Superintendent will visit to inspect the kits within three weeks. Upon inspection of the kits, the tattoo of the doe that kindled fryers will be cross-referenced against the doe validation form to ensure the doe has been validated.

11. The Superintendent/**Assistant Superintendent** can tattoo during a spot check at their discretion.
12. All fryers must be removed from the show barn at the conclusion of the livestock show sale. Any rabbit remaining in the cage the morning after the completion of the livestock show will result in the exhibitor being fined \$50.00.

BREEDING RABBITS

1. All breeding rabbits must be recognized Commercial Type body profile breeds (meat breeds). They must meet weight and breed standards as outlined in the "Standard of Perfection" booklet published by the American Rabbit Breeders Association (ARBA).
2. Each exhibitor will be limited to one entry in each breeding class with a maximum of six entries in the breeder rabbit show.
3. Class changes or substitutions will not be allowed after the entry date.
4. At the time of weigh-in, all rabbits will be sifted by the Sifting Judge as per current ARBA (American Rabbit Breeders Association) standards. The rules are listed in the ARBA Standards of Perfection booklet under "General Faults", "Disqualifications from Competition", and "Rabbit Breed Standards". Any sifted breeder must be removed from the facilities immediately.
5. Grand Champion male and female breeding rabbits will receive an award and \$30.00. Reserve Champion male and female will receive an award and \$20.00. An award will be awarded to the best overall breeding rabbit of the Show. Premiums of \$10.00 for first and \$5.00 for second place will be awarded.
6. Intermediate breeders shall be under 8 months age and adhere to ARBA breed weight standards. Validation date will be set by board of directors.
7. All breeder rabbits must be removed from the show barn at the conclusion of the livestock show sale. Any rabbit remaining in the cage the morning after the completion of the livestock show will result in the exhibitor being fined \$50.00.

PEE WEE RABBIT SHOW

1. The Pee Wee Rabbit Show is open to Kleberg-Kenedy County youth ages 4-8 (who are ineligible to participate in 4-H or FFA because of age or grade level). All exhibitors should attend a supervised educational workshop and must be a member of 4H or Pre 4-H and/or FFA or Pre-FFA group.
2. Rabbits will be New Zealand, Californian, or other ARBA approved Commercial Type body profile breeds (meat breeds).
3. The age limit of the rabbit is 10 weeks.
4. Each exhibitor will be allowed to show only one rabbit.
5. An award will be given to a Grand and Reserve Junior and Senior Showman. Junior ages are 4-5 years of age; Senior ages are 6-8 years of age. Each exhibitor will receive a blue ribbon.
6. All rabbits will be released at the conclusion of the show.
7. Exhibitors will be judged on showmanship skills and condition of project.
8. The exhibitor will be placed in the appropriate age group based on the age of the exhibitor the day of the Pee Wee Rabbit Show.

STOCK HORSE FUTURITY

1. All yearlings are to be born between January 1 and June 15th of the year prior to the show.
2. All animals and exhibitors will be subject to screening by a committee.
3. All exhibitors must be either a 4-H or Vocational Ag member.
4. All animals must be in the possession of the exhibitor for 90 days prior to the show and will be the responsibility of the exhibitor to prepare for show.
5. All yearlings will be judged on showmanship at halter, body condition through feeding and grooming for show.
6. Exhibitors must be in complete control of their animal and only the exhibitor may handle their animal in the show/pen arena or be removed.
7. The show will award \$100 to the exhibitor of the Grand Champion Stock Horse and \$50 to the exhibitor of the Reserve Champion Stock Horse if those horses were bred and originated from herds in Kleberg-Kenedy Counties. Breeders of the Grand and Reserve Champion Stock Horse will be awarded a plaque if those horses were bred and originated from herds in Kleberg or Kenedy Counties.

BEEF CATTLE DIVISION MARKET STEERS

1. Each exhibitor can only enter one market steer.

2. Steers will be divided into the following divisions:
 - A. American Breeds and their crosses
 - B. British Breeds

These animals must exhibit physical characteristics of purebred Angus, Red Angus, Shorthorn, Hereford, or Polled Hereford.
 - C. Exotic – All other breeds and their crosses
3. There will be a minimum weight of 1000 pounds. Steers will be weighed one time only on the official show scale. Weight classes will be determined by division superintendent and assistants.
4. All steers will be sifted and classified by a single classifying/sifting judge.
 - Steers will be classified by their predominate breed characteristics into one of the three divisions. If a steer classes out of American or British division, they automatically roll down to Exotic division.
 - Steers will be sifted based on the following:
 - Quality and health
 - Hair - steers will be clipped to have no more than ¼ inch of hair on any part of the body except the tail at check-in. The tail switch may be ratted, balled, or bobbed off.
 - All steers must be dehorned, with the exception of secondary horn growth.
 - All steers must be shown at halter. The exhibitor must be able to control the animal.
 - The decision of the sifter/classifier is final and not subject to protest.
5. Pumping steers with any substances is prohibited. Steers may be drenched after weigh in to maintain the health of the animal.
6. No tie outs for beef cattle will be assigned. Exhibitors will be allowed to remove beef projects from the barn at exhibitor's discretion, but must return to barn as soon as possible. Grooming will be allowed up to the time the animal is called to the show ring. The exhibitor who is late for their class may not be allowed in the show ring. It is the exhibitor's responsibility to be on time for their class.
7. No parent or handler will be allowed in the show arena during the steer show unless requested by show officials. Exhibitors and cattle must fully exit the show arena before a parent or handler can take control of the animal, including re-haltering or changing of halters.
8. The show will award \$100 to the exhibitor of the Grand Champion steer and \$50.00 to the exhibitor of the Reserve Champion steer if those steers were bred and originated from herds in Kleberg-Kenedy Counties. Breeders of the Grand and Reserve Champion steer will be awarded a plaque if those steers were bred and originated from herds in Kleberg and Kenedy Counties.

JUNIOR COMMERCIAL (PEN OF 2) HEIFER SHOW AND SALE

1. **Purpose:** The purpose of the Junior Commercial (Pen of 2) Heifer Show and Sale is to provide a project that will expose the exhibitors to commercial cattle production. This includes the purchasing, development, exhibition, and marketing of commercial heifers.
2. This show is limited to projects owned, fed and under the daily care of Kleberg/Kenedy County 4-H and FFA members in good standing and under the supervision of the Agriculture Science Teachers and County Extension Agents. The Junior Commercial (Pen of 2) Heifer Show and Sale is an opportunity to show and sell commercial heifers. Any heifer exhibited in the Junior Commercial (Pen of 2) Heifer Show will not be allowed to compete in any other Junior Beef Heifer Show of Kleberg/Kenedy County Junior Livestock Show (KKJLS).
3. **Validation:** This show consists of a pen of two (2) open heifers. To be eligible to show, all junior commercial (Pen of 2) heifer entries will be validated (tagged) at a place to be determined on a date to be determined. A validation fee of \$10 per heifer will be required on the day of validation. Each exhibitor is limited to show only one pen of heifers. Family validation is permitted. One additional heifer can be validated per child. An average weight of no less than 550 pounds and no more than 800 pounds per head will be allowed at validation. Heifers will be weighed by the pen or individually, but the average will be on all heifers in the pen. If a heifer is lost or unable to compete and the exhibitor has only one (1) remaining heifer, that single heifer will be able to sell in the sale but will be ineligible to compete for awards or prize money. Heifers will be palpated at validation. Palpation fee at exhibitor's expense.
4. Exhibitors must own their heifers 100% throughout the feeding period, starting at validation through the time of the show. Exhibitors must feed and care for his/her pen in Kleberg or Kenedy County. The heifers may be grazed or fed and will be judged as replacement heifers. Any exhibitor found to be feeding animals out of the county without proper consent from the KKJLS Board will be disqualified without refund of validation money.
5. **Weigh-In:** Final weigh-in will take place one week before the commercial (Pen of 2) heifer show at TBD between the hours of TBD. Heifers will be palpated at weigh-in. Palpation fee at exhibitor's expense. All heifers are to be guaranteed open and reproductively sound by a licensed veterinarian. Any bred heifer or reproductively unsound heifer will be disqualified. Heifers must average at least 1# per day weight gain from validation date to check in date

- or it will be sifted. Sifting for the show will be enforced at the final weigh-in. Exhibitors are eligible for one re-weigh immediately following their first weigh-in.
6. **Record books:** Record books will be scored out of a possible 50 points. Record books are due on TBD at TBD. An official record book must be used (with no alterations). Information should be correct and legible, with documentation including all expenditures.
 7. **Heifer Judging:** Commercial (Pen of 2) heifers will be delivered to show location on TBD between the hours of TBD. Judging will begin at TBD. All heifers must be shown in their natural form; no clipping allowed. If there are less than two heifers in a pen the score will be zero for the heifer judging portion. **Judging of the heifers will be scored out of a possible of 100 points**, consisting of these criteria:
 - A. Quality and Condition 25 pts.
 - B. Structural Soundness and Confirmation 25 pts.
 - C. Uniformity 25 pts.
 - D. Adaptation to geographical area 25 pts.
 8. **Interview:** Exhibitors will be required to participate in an interview on TBD starting at TBD. Judges will conduct interviews at TBD. Interviews will be based on the exhibitor's knowledge of all areas of his/her exhibit. **Interviews will be scored out of a possible 50 points.**
 9. **Placing Determination and Awards:** Placings will result from the highest accumulated scores from the Interview, Record book, and Heifer scores (**possible 200 points**). Pens will be awarded Grand Champion (Award), Reserve Champion (Award), followed by third place through the final number of exhibits. Ribbons will be given for 3rd-10th places. Premium/prize monies may also be awarded.
 10. **Sale:** The Junior Commercial (Pen of 2) Heifer Sale will be held TBD at TBD. All pens of heifers are required to sell. The pens will sell in placing order. Pens with less than two will be placed last on the sale order. Exhibitors will have the option of selling their alternate (3rd) heifer through the ring at the conclusion of the placed heifer sale once the final lot has been sold. Beef Checkoff fees will be deducted per the National Law on the Beef Checkoff. A sales commission will/may be deducted from the sales price of each heifer to offset any marketing costs incurred by the sale contractor. **Junior commercial (Pen of 2) heifer exhibitors are eligible to still sell one additional animal through the normal "Premium Auction."** The buyer has first right of refusal on the exhibitor's alternate (3rd) heifer at the time of sale.
 11. Minutes of the committee meetings will take precedence over any typo or inconsistency that may be found in the rulebook as minutes have been accepted and voted on as per Roberts Rule of Order.
 12. There will be NO harassment of the judge(s) and/or commercial (Pen of 2) heifer committee prior to, during or after the show. Judges reasons for their placing will be considered adequate explanation for their placings.
 13. This program is designed to be educational and beneficial to the youth of KKJLS. Any parent or exhibitor not adhering to rules of the program will be subject to discipline per general and livestock rules laid out by KKJLS.

BREEDING BEEF CATTLE

1. Premiums of \$50.00 for first place will be paid in the Heifer and Bull classes. The exhibitors of the Grand Champion Heifer and Bull will receive an award.
2. All animals are to be validated as stated in the validation section.
3. No more than two entries per exhibitor per class.
4. All breeding cattle will be sifted and classified by a single sifting/classifying judge at check-in.
 - Breeding animals will be classified by predominate breed characteristics into one of the three divisions.
 - American, British, or Exotic.
 - Breeding animals will be sifted based on the following:
 - Quality and health
 - All animals must be shown at halter. The exhibitor must be able to control the animal.
 - The decision of the sifter/classifier is final and not subject to protest.
5. Classes will be as follows:

If there are 3 or more head of a particular breed, those animals will show separately in their respective division. Each of the breed champions will then compete for the division champion.

- All breeding beef animals must not be missing more than two middle temporary incisors. If a question of doubt exists on the age of the breeding animals, the sifting judge will tooth the animals to determine age. The decision of the sifting judge will be final.
- All females 24 months of age and older on the day of the show must be palpated "Safe-in-calf" at least 30 days previous to the show. A certificate from a veterinarian certifying that cow is "Safe-in-calf" and approximate term of gestation on date of palpation, will be presented at check-in. Certificate is not needed if cow has calf 4-6 months or younger at side.
- No animal will be allowed past the sifting judge without age and breed being verified.
- All breeding bulls must have a permanent bull ring in their nose. Heifers and bulls with horns must have them tipped, cleaned and smoothed. Exemption: longhorns due to being a characteristic of the breed.
- Bulls must not have exceeded their 24 month birth date. Heifers must not have exceeded their 30-month birth date.
- No parent or handler will be allowed in the show arena during the breeding beef show unless requested by show officials. Exhibitors and cattle must fully exit the show arena before a parent or handler can take control of the animal, including re-haltering or changing of halters.
- For the safety of the exhibitors, the beef cattle superintendent along with the beef cattle committee will split large classes as they deem necessary.

PEE WEE CATTLE

- The Pee Wee Cattle Show is open to Kleberg-Kenedy County youth ages 4-8 (who are ineligible to participate in 4-H or FFA because of age or grade level). All exhibitors should attend a supervised educational workshop and must be a member of 4H or Pre 4-H and/or FFA or Pre-FFA group.
- Cattle may be any breed or crossbreed, steer or heifer. Calves must not weigh more than 500 pounds at the time of validation. All breeding beef animals must not be missing more than two middle temporary incisors at the time of validation.
- At county validation a county validation tag will be placed in the calf's ear. This serves as an immediate family validation. However, each exhibitor involved must have an entry in the Pee Wee Cattle division. Each validated

- animal may only be shown by one exhibitor the day of the show. These animals may not be validated or shown in the market or breeding show by any other exhibitor.
4. Validation will be held on the 1st Sunday of December, time and location to be announced. Exhibitors must be present at validation. There will be a \$5.00 validation fee due at validation.
 5. On show day calves must be in good general health. The show will begin as quickly after check-in as possible.
 6. Pee Wee will be Showmanship Classes only.
 7. Pee Wee Cattle Exhibitors may enter the ring with the assistance and guidance of a registered KKJLS cattle division participant. These older members providing assistance are there to keep the Pee Wee exhibitors safe and keep room between animals. They are not to take complete control over the animal unless a safety situation calls for them to do so. Pee Wee exhibitors may be excused from the ring if they are unable to maintain control over their animal.
 8. An award will be given to a Grand and Reserve Junior and Senior Showman. Junior ages are 4-5 years of age; Senior ages are 6-8 years of age. Each exhibitor will receive a blue ribbon. Exhibitors will be judged on showmanship skills only.
 9. All calves will be released at the conclusion of the show.
 10. Pee Wee Junior ages are 4-5 years of age; Pee Wee Senior ages are 6-8 years of age. Age of exhibitor will be their age at day of all Pee Wee Cattle Division shows.

HERDSMAN AWARDS

Herdsmen Awards – A five (5) person Herdsman Selection Committee shall be appointed by the President of the association each year to serve for the following year's show and shall be made up of three (3) division superintendents or assistant superintendents and two (2) association members in good standing that are willing to serve on the committee. This committee shall have as many meetings as they deem necessary during the annual show to obtain enough information as to the qualified recipient of each award. An award will be presented in Beef, Swine, Poultry, Lamb, Rabbit, Stock Horse, and Goat Divisions to the 4-H club or FFA Chapter and to the individual exhibitor that does the best job of keeping their project and area in the most showmanship fashion during the entire show. The Herdsman Selection Committee's decision must be made and reported to the livestock show office by 10:00 p.m. on Friday.

SHOWMANSHIP CONTEST

The purpose of this contest is to make showmanship an education activity and to emphasize to 4-H and FFA members the value of proper showmanship techniques.

1. An award will be awarded to Grand Champion Showman and Reserve Champion Showman of the Junior, Intermediate, and senior exhibitors of each of the divisions of Beef, Swine, Rabbit, Lamb, Goat and Farm Shop. All exhibitors will be judged on who does the best job showing his or her project.
2. All exhibitors of Beef, Swine, Rabbit, Lamb, Goat and Farm Shop projects will be evaluated on their showmanship abilities as exhibited during the judging of their project in their respective classes. All livestock exhibitors will be required to wear numbers while exhibiting their project.
3. Division superintendents, working with their committee members, will determine the method to select showmanship contestants within their respective divisions.
4. A Junior, Intermediate and senior division will be established. The Junior division will consist of exhibitors 8-10 years of age. The Intermediate division will consist of exhibitors 13 years of age and under. The senior division will consist of exhibitors 19 years of age and under. Ages are as of September 1st.
5. The judge for the showmanship contest will be one out-of-county judge that is familiar with proper methods of showing livestock. The Farm Shop Judge will be one out-of-county judge that is familiar with proper presentation of farm shop exhibits.
6. All exhibitors must exhibit their own project at all times in the showmanship contest, unless otherwise directed by the judge during the contest.

YOUTH HOMEMAKING DIVISION

DIVISION

1. **Rules and Regulations:** All entries must comply with the general Rules and Regulations of KKJLS. Please refer to the General Section and Eligibility Section of Kleberg-Kenedy County Junior Livestock Show Rule Book, as well as the Youth Homemaking Division rules. Failure to comply with the rules will result in disqualification of entry or

- entries. In addition, failure to comply with individual homemaking project section rules, will also result in disqualification of entry or entries, and said disqualifications may occur at any point from check in to pick up.
2. **Age Divisions:** All age divisions are decided by exhibitor's age as of September 1st prior to the stock show. Age divisions are: Juniors (8-10) Intermediate (11-13) Senior (14-19)
 3. **Sections or Categories:** Cakes, Cookies, Candy, Yeast Breads, Sewing, Mixes Plus, Preserved Foods, Quick Breads, Photography, Recycled, Canvas Arts, Creative Arts, Industrial Arts, Decorative Arts, Sugar Free Desserts. Please refer to the Individual Section Rules to ensure your project is placed in the correct section or category
 4. **Entry:** All entries and fees will be processed online according to Entry Section. Exhibitor may enter one entry per category. Switching categories is not allowed. Placing an entry in the wrong category is grounds for disqualification. Review category rules carefully! There will be NO switching of categories at ANY TIME. There will be no refunds if an exhibitor decides to cancel an entry in any category.
 5. Validation will be online, by sending email using the approved format, or filling out an online form (found on the KKJLS website), there will also be a one day in person validation that will take place at a central location to be determined at the start of the stock show season (to be announced via KKJLS website).
 - Online validation:
 - Food projects: copy of the recipe, ingredients must be listed in the order they were used.
 - Photography projects: title, brief description of when, where, and why photo was taken, what if any, special effects were used, etc.
 - All other non- food projects: title, category, materials, and instructions or procedures must be provided in the order they were used.

In person validation, two copies of the above information must be typed or printed on front and back of white non lined 4x6 index cards. If more than one card is used, paperclip and number the cards. Examples will be on the KKJLS and Agrilife Extension website.
 6. **Check in:** Entries must be delivered by the exhibitor along with the one page portfolio (if required) and the pattern for sewing projects, by the exhibitor to the JK Northway on Monday evening from 5:00pm to 8:30pm on the Monday immediately prior to stock show. Entries must be the work of the exhibitor and constructed or made within 365 days of the end of the previous show. Entries must fit through a single doorway, and be completely assembled. Wheels are allowed on projects only if they are part of the original design and permanently fixed to the project. No outside items such as Bar-B-Que pits, picnic tables, outside furniture, bird baths, etc. are to be entered in Youth Homemaking. Those are covered under the Farm Shop Projects. The exhibitor must participate in the check-in process.

Please note: No parent or exhibitor will be allowed in the exhibiting area during check in, judging or tabulating unless they are a Youth Homemaking superintendent, part of the Youth Homemaking committee, or an appointed tabulator.
 7. All non-food and non-photography projects are required to turn in a portfolio at check in. A portfolio is a single page document containing only three pictures and their descriptions. Picture one is of the materials, picture two is a mid-point photo, and picture three is a photo of the final project. Use the descriptions to let the judges know how long it took to complete your project, and/or describe any changes that might have not been listed on your original project index cards. Neither your face nor name can appear anywhere on the portfolio or the project.
 8. **Judging:** Judging will take place on Tuesday beginning at 9:00am. Only the judges, section chairman, division superintendent, and tabulators will be allowed in the meeting room while judging takes place. Superintendents will monitor all judging. All entries will be judged by two judges per category, per age division. **Awards:** Once all entries are judged, entries will receive a Blue Award (90-100 points) or a Red Award (80-89 points). In addition, one division winner per category per age level will be chosen and awarded a rosette. Once Rosettes are chosen, those wishing to be judged for Grand Champion are placed on a table, and five new judges are brought in to judge for the Grand and Reserve Champion. During the entry process, the exhibitor decides whether they want their project judged for Grand. The exhibitor has the option to change the decision to be judged for Grand during the check-in process. No changes can be made after check-in. The projects being judged for Grand are placed on the table and each entry has their previous two judging cards removed and filed for use after judging. The entries are then given five new judging score cards. These score cards correspond with the entry. For example, a cake will be judged using "cake" scorecard, an industrial arts project with an "industrial arts" scorecard and so on. The five judges will independently judge using corresponding scorecards. Judges will then turn in their score cards for each entry. After tabulation, an assistant will then enter all scores into a spread sheet, where scores will be averaged. In the event of a tie, there is a tie breaking system in place, utilizing a certain section of the scorecard. The entry with the highest average is our Grand Champion. The entry with the second highest average is the Reserve Grand Champion. Grand Champion and Reserve Grand Champion are required to sell in the "Auction Sale". If an exhibitor wins both Grand and Reserve in the homemaking division, only one project will sell in the "Auction Sale" The rosettes may sell in the Silent Sale during the stock show. Rosettes that are allowed to sell at the Silent Sale are NOT considered as an entry that is sold at the stock show "Auction Sale". Please refer to the general rules - exhibitors will only be able to sell one entry from all entries at the stock show "Auction Sale".
 9. **Viewing of entries:** Viewing of entries be open 6:00 p.m. -8:00 pm on Wednesday, 9:00 a.m-7:00 p.m. on Thursday, and 9:00 a.m. - 3:00 p.m. on Friday.

10. **Silent Sale:** Those entries receiving Rosettes will be responsible for reading their form attached to their rosette. This form will inform exhibitor of when they need to be available for pictures, what is expected for the silent sale, and when to be available for the silent sale. If an exhibitor chose at registration to participate in the silent sale, it is understood they will sell that item if they are chosen a rosette winner. In the event that a participant is chosen as a rosette winner, and they chose at registration to NOT participate in the Silent Sale, an alternate may be chosen if the superintendent and her committee deem it qualified to sell; meaning it must be of quality to sell and have a score comparable to the rosette winner (not off by more than two points and must be a blue ribbon). In addition, a child receiving multiple rosettes (they shall only sell one rosette at the silent sale), their categories may be filled by an alternate, which is up to the discretion of the superintendent and provided that the next higher score is of quality to sell and within two points of the rosette winner and awarded a blue ribbon.
11. **Pick up:** All entries must be picked up and removed from show grounds on Friday between 3:00 pm-5:00 pm. Any entries left on show grounds (including dumpsters) will be charged a \$50 disposal fee.
12. **General project rules/information:**
 - a. Recipes become the property of KKJLS and may be used for publication.
 - b. No items requiring refrigeration may be used.
 - c. No non-edible embellishments may be used (no cake boards, napkins, doilies, lollipop sticks, paper cones, cupcake liners, etc).
 - d. Project must be prepared, built, constructed, painted or photographed within ONE calendar year of the previous stock show.
 - e. No alcohol may be used in ANY recipe.
 - f. No mixes may be used in any projects other than Mixes Plus category. Mixes are defined as cake mix, pudding mix, icing mix, pancake mix, muffin mix, cookie mix, etc.
 - g. No canned biscuits, canned crescents, pre-made cookie dough, pre-made pie crusts, phyllo dough, etc may be used in any recipes.
 - h. With the exception of preserved foods, all food items must be displayed in containers provided by the stock show. Please make sure your recipes fit in the containers provided by KKJLS.
 - i. **Sample judging score cards will be on the KKJLS website.**

INDIVIDUAL RULES FOR EACH HOMEMAKING CATEGORY

CAKES

1. Must be displayed as an entire item (whole...not cut) in adherence to the recipe.
2. No mix of any kind.
3. Must be displayed without cake board or any non-edible embellishments, in container provided.
4. Containers provided may be: 10" round (bundt and layered); 13x9x2 (stay in pan); 13x9 (cake to be removed from pan or a ½ sized jelly roll pan, cupcake container (4)).

MIXES PLUS

1. Must be displayed as an entire item (whole...not cut) in adherence to the recipe.
2. May be a cake, cookies, bar, bread, sugar free, muffin, cupcake, etc.
3. A mix is used as the base of the recipe with various ingredients to enhance the flavor and/or appearance. Mix is defined as cake mix, brownie mix, biscuit mix, cookie mix, etc. NO refrigerated biscuits, refrigerated cookie dough, frozen rolls, phyllo dough, etc. may be used.
4. Must be displayed without cake board or any non-edible embellishments, in container provided.
5. Container provided will vary with the type of recipe used. (see cake, bread, muffin, cookie, candy to see size of containers)

PRESERVED FOODS

1. Must be preserved within a calendar year of prior show, and might be jerky, salsa, jelly, jams, sauce, etc.
2. MUST be displayed in a sealed canning jar or other vacuum sealed container provided by exhibitor.
3. Two sealed jars or vacuum sealed containers **MUST** be provided. Both jars or containers **MUST** have a label with the date of canning clearly marked, as well as the type of food it is. Jars or containers with broken seals will not be judged and will be disqualified.

QUICK BREAD

1. Must be displayed whole in adherence to the recipe.
2. May be loaf, muffins, rolls, or any bread that fits into a container provided by KKJLS.
3. May not contain yeast, therefore no refrigerated biscuits, crescent rolls, or pre-made frozen dough of any kind may be a part of the recipe.
4. Must be displayed in container provided by KKJLS.
5. Container sizes for loaves will be a disposable loaf pan (approx. 1 ½ pound), muffins will be placed in a muffin container displaying four, biscuits/rolls will be displayed in plastic containers, and other containers may be provided

if an unusual recipe presents itself, but that is up to the discretion of the superintendent and the Youth Homemaking committee.

YEAST BREAD

1. Must be displayed whole in adherence to the recipe.
2. No refrigerated biscuits, rolls or other premade dough may be used in this recipe.
3. Must be displayed in the container provided by KKJLS.
4. Container sizes for loaves will be a disposable loaf pan (approx.. 1 ½ pound), muffins will be placed in a muffin container displaying four, biscuits/rolls will be displayed in plastic containers, and other containers may be provided if an unusual recipe presents itself, but that is up to the discretion of the superintendent and the Youth Homemaking committee.

COOKIES AND CANDY

1. Place as many cookies or pieces of candy as possible to make it look attractive. Must be at least six.
2. No doilies, cardboard, napkins, sticks, paper cones, etc. are allowed in the container.
3. Must be displayed in container provided by the KKJLS. Containers available are approximately 6x4x4 rectangular, 8X8 square, or container approved by the superintendent and committee (allows for changes in sizes of containers available for purchase).

SUGAR FREE DESSERTS

1. Must be displayed as is appropriate for recipe.
2. No mixes of any kind allowed in this category.
3. Must be displayed in container provided by KKJLS. Containers provided will vary with the recipe, but must be one of the sizes mentioned in the above categories. No non-edible embellishments allowed.

SEWING

1. Items made exclusively on a sewing machine.
2. For example: machine quilted, machine appliqued, combination, small wall hangings, clothing, doll accessories, baby clothing, blankets, pillows, pillow cases, pet apparel, etc.
3. Entries must be on a hanger and enclosed in plastic to protect the project from damage.
4. One page portfolio and pattern must be present, if entry was done without a pattern the exhibitor must include their own instructions.

CREATIVE ARTS

1. Projects are created from scratch, hand-stitched, hand-strung, or hand-made. For example: hand-stitched quilts, embroidery, cross-stitch, latch hook, macramé, crochet, beading (jewelry, necklaces, bracelets, earrings) or other hand-made accessories.
2. One page portfolio must be present.
3. Entries must be placed in plastic to protect it from damage. Place on a hanger when appropriate
4. Project must fit through a single doorway.
5. No power tools may be used in this category.

DECORATIVE ARTS

1. Projects that are made from existing items and simply embellished with paints, fabrics, ribbons, etc. For example: Floral arrangements, wreaths, decorative picture frames, painted step stools, etc.
2. One page portfolio must be present.
3. Entries must be placed in plastic to protect it from damage. Place on a hanger when appropriate.
4. Entries must be in judging condition, completely assembled, and fit through a single doorway.

INDUSTRIAL ARTS

1. Project using power tools and machinery. Typically made of wood, metal, plastic, glass or leather.
2. Entries must be in judging condition, completely assembled, and fit through a single doorway. No large outside items such as fire pits, swings, bar-b-Que pits, picnic tables, outdoor furniture, etc. will be allowed to be judged against other Youth Homemaking projects.
3. One page portfolio must be present.

RECYCLED ARTS

1. Any project that is completely composed of recycled materials. All items must be recycled items. It could include old tires, small furniture, pallets, old paper goods, juice wrappers, etc. Only allowable purchased items can be: paints, glue, thread, etc.
2. It must take on a new life. For example: an old end table could become a dog bed; feed sack could become an apron; old tire could become a stool.

3. Entries must be in judging condition, completely assembled, and fit through a single doorway. One page portfolio must be present.

PHOTOGRAPHY

1. Photos must be 8X10, must be vacuumed, dry or flush mounted with no mat, and placed in a plastic sheet protector.
2. There are no restrictions on subject matter, other than restrictions listed in general rules: no alcohol, tobacco, etc. Photos must be in good taste. Exhibitors name and face may NOT appear in the photo or on the photo.
3. Reminder: photo entries are required to have the same project instructions as all other homemaking projects. (i.e. title, brief description of when, where, and why photo was taken, what if any, special effects were used, etc.) The type of camera used is to be noted on the validation card.

CANVAS ARTS

1. Artwork done exclusively on art paper or canvas and created by exhibitor.
2. Mediums utilized may be crayon, ink, pencil, charcoal, watercolor, oil, pastels, etc. No decorations may be included.
3. One page portfolio must be present.
4. Artwork must be enclosed in plastic for protection, and if using paper, it must have a cardboard insert to protect it from damage.

FARM SHOP DIVISION

1. All farm shop exhibits are to be completed, painted, and dry prior to bring to the show. At the time of judging, all exhibits must be free of decorations and visual aids including but not limited to: Firewood, coolers, televisions, propane tanks, coverings. Power supplies for trailer lights and project operations shall be permitted.
2. Exhibitors may enter one project in each of the EIGHT classes, but no exhibitor may enter more than one project in a single class.
3. All farm shop exhibits will be checked in to the show by each/all of the exhibitors for each project on Tuesday between 9:00 a.m. and 12:00 p.m. Exhibitors not present are deemed ineligible and shall be removed from the entry upon check in.
4. Entries will be divided into Intermediate and senior sub-divisions.
 - A. Intermediate exhibitors are defined as ages 8-13 as of September 1.
 - B. Senior exhibitors are defined as ages 14 and up as of September 1.
5. Entries will be categorized into the appropriate classes for judging.
 - A. Trailer Class
 - 1) All size trailers
 - B. Shop and Electrical Equipment Class
 - 1) Shop, tools and equipment, non-electrical
 - 2) Shop, tools and equipment, electrical
 - 3) Light stands and other electrical equipment
 - C. Agricultural Machinery and Equipment Class
 - 1) Hay handling equipment
 - 2) Spraying Equipment
 - 3) Mounted/pull type tractor equipment
 - 4) Truck accessories
 - 5) Hydraulic equipment
 - D. Livestock Equipment Class
 - 1) Gates and panels
 - 2) Squeeze chutes/restraining equipment
 - 3) Trim chutes/blocking stands/livestock crates/head gates
 - 4) Livestock feeders
 - E. Farm and Home - Metals
 - 1) Deer blinds
 - 2) Bar-B-Que pits and outdoor cooking accessories
 - 3) Wildlife feeders/Hunting accessories
 - 4) Any combination wood - metal project containing more than 50% metal
 - F. Farm and Home - Wood
 - 1) Home furnishings
 - 2) Patio/Porch swings or furniture
 - 3) Picnic Tables
 - 4) Deer Blinds
 - G. BBQ Pit Trailers

- 1) All size BBQ pit trailers
- H. Tractor Restoration (Not eligible to compete for Grand/Reserve Overall)
 - 1) 1950 and older
 - 2) 1951 - 1960
 - 3) 1961 - 1996
- 6. There will be a Champion and Reserve Champion in large metal division (Class A&G), small metal division (Class B-E), wood division (Class F) and tractor restoration (Class H). The judge will score and rank all projects in each of the eight classes in the intermediate division and each of the eight classes in the senior division. The judge will select a first and second place project from each of the eight classes in the intermediate division and each of the eight classes in the senior division. The Grand Champion of the show will be chosen from one of the division champions and will receive an award. The Reserve Grand Champion of the show will be chosen from one of the division champions and will receive an award. All blue ribbon winners will receive a cash award of \$30.00. The decision of the judges will be final in all cases, except where mistakes, fraud, misrepresentation, or collusion not discovered at the time of the award is proved. In such case, the General Superintendent, or such referee as he may appoint, may make decision, or the case may be referred to the Executive Committee, from whose decision there can be no appeal. The following scores will be used to award ribbons:

Blue (Excellent)..... 90-100
 Red (Good).....80-89
 White (Fair).....70-79
 This is to be inserted after the score card points.

The Farm Shop Committee has the authority to place exhibits in the most appropriate class for judging. The following score card will be used in judging entries:

- A. Workmanship 40 points
- B. Sound structural designs and balance 30 points
- C. Degree of difficulty 10 points
- D. Plans, photos of construction, bill of materials 10 points
- E. Practical utility 5 points
- F. Ability to answer judges questions 5 points

- 7. Farm shop exhibits may be individually or group constructed by bona fide 4-H, FFA and/or FCCLA members. A team project will be limited to four members. All team member names must be submitted at time of entry. Any project constructed by a group consisting of one or more seniors, will be entered in the senior division.
- 8. All exhibitors must be stationed by their farm shop project for questioning by the judge during the judging of the exhibits. The exhibitor must come back to answer questions by the judge if he/she is showing a project. There will be no penalty for the exhibitor not answering questions if he/she is showing their animal. (Ex. Swine). Plans, photos, and bill of materials shall be displayed on the project in such a manner that no additional floor space is required.
- 9. All exhibitors will use appropriate measures to ensure the safety of everyone. Precautions will include, but are not limited to: Any project containing sharp edges and/or points will be padded. The Farm Shop superintendent and the Farm Shop committee will make the final decision on the safety precautions needed of each project. Safety devices will be removed during the judging only.
- 10. The over-all Grand Champion and over-all Reserve Grand Champion will sell in the "Auction Sale". Projects consisting of more than one team member will have sale price at auction divided among the number of members exhibiting the farm shop project. Exhibitors will only be able to sell one entry from all entries at the livestock show "Auction Sale". A team member may wish to sell a different project in the auction and the remaining members will divide the proceeds from the Grand and Reserve Champion over-all Farm Shop projects.
- 11. Shop projects do not participate in the resale process. Therefore, exhibitors must remove all shop projects from the grounds by 12:00 noon on the day after the auction sale.

AUCTION SALE SECTION

- 1. The following are the number of animals/projects in each division that will be sold each year: 30 Market Steers, 4 Horses, 75 Swine, 68 pens of Broilers, 25 pens of Rabbits, 30 Market Lambs, and 40 Market Goats, 2 Youth Homemaking and 2 Farm Shop projects sold. Animals will be sold by the head or pen. Placing order along with the class will be added to the sale catalog printed for the auction sale.
- 2. The auction sale order will be rotated each year. Each division will move up a step and the project that sells first in 2017 will move to last. Beginning in 2018 the order of the sale will be: Youth Homemaking, Swine, Broilers, Rabbits, Goats, Lambs, and Steers, Stock Horse Futurity Yearlings, and Ag Farm Shop..
- 3. The Kleberg-Kenedy Junior Livestock Show Sale is a premium sale. The association will receive floor bids for all livestock and market projects whenever possible. The exhibitor has to declare whether they want the project or the

floor value of the project at check-in time with the exception of rabbits and farm shop projects. **The exhibitor has until the conclusion of judging on Friday evening to change the disposition by filing a form with their respective superintendent accompanied by a \$25.00 penalty.** Regardless of whether the exhibitor chooses the floor value or the project, the association will receive full commission on the project. The floor values will be listed on the sale sheet at the auction. The buyer may take possession of a project by paying the floor value. If the buyer takes possession of a market animal, the KKJLS will provide an animal of equal or greater market value to the buyer if the exhibitor wishes to retain possession of the project. At the buyer's discretion, the project may be donated to a charity.

4. Each exhibitor will be limited to sell only one entry in the auction sale. The Homemaking Rosette Silent Sale is NOT considered a project that has been auctioned. Withdrawal of entry from the auction must be made before 6:00 p.m. the Friday before the sale unless you have a project that has not been judged. If a project still needs to be judged, then the exhibitor will have 1 hour after judging is complete to declare which project to sell. If the exhibitor fails to declare which animal or project to sell prior to this deadline, then the General Superintendent, working with the division superintendents, shall make the final determination of which animal or project to sell. All Grand and Reserve Champions must sell, unless the exhibitor exhibits more than one Grand or Reserve Champion at which time the exhibitor will have a choice of which project to sell **with the exception of Youth Homemaking. Youth Homemaking must sell their Grand and Reserve homemaking projects.** During the entry process, the exhibitor decides whether they want their project judged for Grand. The exhibitor has the option to change the decision to be judged for Grand during the check-in process. No changes can be made after check-in. If an exhibitor wins both Grand and Reserve in the homemaking division, only one project will sell in the "Auction Sale" If the Grand or Reserve Champion Farm Shop project is a team entry and one or more team members have additional project(s) eligible for sale, the individual must choose ONE project to sell, either the team project or his/her individual project.
5. All exhibits must be on exhibit Saturday at least one hour before beginning of the auction, and remain on exhibit until called for by Superintendent or Assistants.
6. Sale animals and order will be determined by the judge for each division. Stock Horse Futurity yearlings and poultry will sell in the order of placement by the judge. Sale order for Beef, Lamb and Goat Divisions will be determined as follows: (Rabbit sale order is defined in the market rabbit section.)
 - A. If there are fewer entries than the number to sell then the Grand Champion will sell first and the Reserve Champion will sell second. The remaining entries sale order will be by a random drawing of the remaining Breed Champions, then the remaining Reserve Breed Champion, then the remaining 1st place in each class, then the remaining 2nd place, 3rd place, etc. This method will be followed until all animals have been assigned sale order.
 - B. If there are more than the number to sell then the judge of the division will determine sale animals and order by the following method.
 1. The Grand Champion will sell first and the Reserve Champion will sell second.
 2. The remaining Breed Champions shall compete for the next sale position.
 3. As each Breed Champion is selected then the Breed Reserve will be brought to the ring.
 4. Once the Breed Reserve is selected then the top place animal in each weight class for that breed will be brought, into the ring.
 5. As each animal is selected then the next place animal in that weight class will be brought into the ring.
 6. This process shall continue until the total number of sale animals plus the required alternates have been selected. (The number of alternates shall be determined by the Division Superintendent.)
 7. All sale animals shall receive a blue ribbon and all others a red ribbon.
 - C. Sale order for the Swine Division: (If there are more swine entries than the number to sell) will be determined as follows:
 1. The Grand Champion will sell first and the Reserve Champion will sell second.
 2. The remaining Breed Champions and Reserve Breed Champions shall compete for the next sale position. (by judges selection process)
 3. The remaining pigs to complete the sale order will be determined by the following method. The total number of pigs to sell will be divided by the total number of pig entries that officially qualified to show, resulting in the percentage from each class to sell. (Example: 75 hogs sell, 105 hogs officially check-in and make it through the sift $\sim 75/105 = 71.43\%$ of each class will qualify for the auction. A class of 12 entries will have 9 that qualify for auction. A class of 9 entries will have 6 that qualify for auction.) The Grand Champion, Reserve Champion and other breed champions will count towards the allowable percentage of their respective class.
 4. The process of selection will be as a random lottery of the remaining 1st place pigs, followed by the 2nd place pigs, followed by the 3rd place pigs, etc. until all sale spots are filled. All sale animals shall receive a blue ribbon and all others a red ribbon.
7. No animal sold in the auction sale is to sell higher than the Grand Champion in its respective division.
8. 0% to 7% commission may be deducted from all sale animals and birds to help defray expenses of the show.
9. Transportation of all sale animals following the show is the responsibility of the General Superintendent.

10. A complete record of all sales will be kept by the association bookkeeper and sales clerk to assist in settlement between buyer and seller.
11. Farm Shop Exhibitors, excluding Grand and Reserve Champions, wishing to sell their projects while on show grounds must do so through the KKJLS Office and are subject to the commission that all other sales incur. Private treaty sales/bid sheets not authorized by KKJLS are prohibited and will result in the exhibitor(s) being ineligible to participate in KKJLS for a period of one (1) year.
12. Sale orders will be submitted to the General Superintendent by the division Superintendent within ~~2~~ 3 hours of the end of the individual division show. In the event that a sale order is not submitted within that time frame, the General Superintendent will determine the sale order for that division.

HORSE SHOW DIVISION

1. **Current state 4-H Horse Show rules will apply to all judged events on an individual event basis. Timed event classes will follow current Youth Rodeo Associations' timed event rules on an individual basis.**
2. All horses on site must have current Negative Coggins papers.
3. Classes to be determined by Horse Show Committee.
4. Exhibitor's age division is as follows: Pee Wee (Age 4 - 2nd grade), Junior (3rd-5th grade), Intermediate (6th-8th grade), Senior (9th-12th grade). Grades are as Sept 1st. Pee Wee age 4 is as of the day of the horse show.
5. Exhibitor or Exhibitor's family does not need to own the horse; however it is highly encouraged that the exhibitor takes possession of the horse at least 60 days prior to show.
6. Contestants may show more than one horse or two or more riders may compete on the same horse in patterned and timed event classes excluding showmanship.
7. State 4-H Horse Show Equipment rules (split reins, hackamores, tie downs, etc.) do not apply to Pee-Wee or lead-line classes.
8. Any lead-line classes offered will not go towards any high point awards. Only the rider is required to adhere to the dress code.
9. **Class points will be awarded as follows: Each of the first 10 horses in a class will be given a point for each horse placing below it, plus one point for a maximum of 10 points. For example, in a class of 10, first place receives 10 points, second receives 9 points, and so on through tenth place which receives 1 point. A broken pattern or No Time in times events shall NOT receive points.**
10. Only yearling stallions will be allowed to show (no stallions over 1 year old).
11. **Tie Breaker Guidelines:**
 - a. **For Performance Champion: 1. Higher placing in greater number of classes within the division (except halter classes). 2. Exhibitor who placed higher in a class designated by the Horse Show committee to be the tie-breaker class.**
 - b. **For Timed Champion: 1. Higher placing in greater number of classes within the division. 2. Exhibitor who had the lowest combined time within the timed event classes.**
 - c. **For All Around Champion: 1. Higher placing in greater number of classes. 2. Greater number of horses placed over in all classes.**
 - d. **In the event of an unbreakable tie, the award will be split equally and co-champions will be named.**
12. **Performance, Timed Event, and All Around Champion Qualifications:**
 - a. **Performance Champion is awarded to the contestant with the highest number of points in judged classes (except halter classes).**
 - b. **Timed Event Champion is awarded to the contestant with the highest number of points in timed event classes.**
 - c. **All Around Champion is awarded to the contestant with the highest number of points in all classes (except halter classes).**

QUEENS CONTEST

1. There will be 3 categories: Junior Queen (Elementary School 3-5 grades), Intermediate Queen (Jr. High 6-8 grades), and Senior Queen (High School 9-12 grades). All contestants must be enrolled in school, be single and never have been married. Ages as of September 1st.
2. In each category there will be a winner, first and second runner-up.
3. **Contestants must be member of any 4-H, FFA, FCCLA club in Kleberg-Kenedy Counties since September of the current school year. Each contestant must have a project entered in the Livestock Show.**
4. Each club or organization may submit three candidates - one from each category.
5. **Queens contest entry and fee will be processed online according to Entry Section and is due by the deadline set for all livestock show entries.**
6. Contestant must comply with rule #9. If this requirement is not met, the contestant will be billed a \$100 non-compliance fee. This fee will be deducted from the current year's exhibitor's KKJLS Auction proceeds or must be paid prior to the NOV 1st KKJLS ENTRY DEADLINE for the following year's show.

7. Queens contest packets will be available for download on the KKJLS website. All contestants are required to submit packet and photo to Division Superintendent prior to the pageant.
8. The Senior Queen, Intermediate Queen and Junior Queen and as 1st and 2nd Runner-Ups shall preside over the Kleberg-Kenedy County Junior Livestock Show to present awards at various judging events and at the official awards ceremony.
9. Contestants are required to comply with the following
 1. Attend the practice session to be announced.
 2. Participate in the Parade
 3. Be present at auction sale to assist where needed during their scheduled shift.
10. Previous winners of a particular division are ineligible for competition in that division. They must compete in one of the other divisions provided grade requirements are met.
11. Contestants will randomly draw their individual contestant number at rehearsal. Numbers cannot be assigned or switched with other contestants.
12. No parents, friends, hairdressers, etc. will be allowed backstage during the pageant. Only contestants and authorized personnel will be allowed backstage. Anyone that is not either a contestant or event staff must leave the staging area 45 minutes prior to the start of the event. **NO CELL PHONE WILL BE ALLOWED BACKSTAGE.** Queens contest staff will be available to aid contestants with last minute details. Contestants are expected to bring everything they need to compete in the pageant. Queens contest staff will not have nor provide safety pins, bobby pins, etc.
13. Pageant Judging and monitoring will consist of 3 judges and 1 accountant/auditor.
 - A. Accountant/auditor will sit at table with the 3 judges during the Queen's contest.
 - B. Judges will perform the initial tally of score sheets, sign, and personally hand to the account/auditor. The accountant/auditor will perform second tally to double check all scores.
 - C. At Queen's contest the accountant/auditor will confirm total scores for each division and personally hand final results to the Master of Ceremony. The Master of Ceremony will confirm with the accountant/ auditor verbally before announcing the winners on stage.
14. All score sheets will be available to be picked up by a contestant/parent immediately following the conclusion of the pageant. Any score sheets not picked up that evening, will be sent to the email designated on entry form by the division superintendent.

4-H & FFA LIVESTOCK JUDGING CONTEST

1. A team consists of no less than three members and no more than four.
2. Teams will be divided into Senior, Intermediate, and Juniors. Senior (ages 14-19), Intermediate (ages 11-13), Junior (ages 8-10) age as of September 1st.
3. Members must be bona fide 4-H and FFA members of good standing.
4. Market and Breeding classes will be judged. Questions will be asked.
5. Each class will have four animals.
6. Animals within a swine class will be designated by numbers 1, 2, 3, 4, and all other classes will be judged left to right.
7. Contestants will be allowed 10 minutes to judge each class, 2 minutes to view, 6 minutes to judge, and 2 minutes to view.
8. Contestants will be notified one minute before time is up. When final time is called, the contestants will hand their scantron sheets to the group leaders.
9. Each group of contestants will change to another class as directed by the group leader.
10. While the contest is in progress, there will be no talking between contestants and anyone else.
11. A contestant violating any of the rules will cause himself and the team of which he is a member to be disqualified for all awards.
12. Scores will be based on placing only.
13. Each member of the Senior, Intermediate and Junior teams will receive an award. Top 3 teams will be awarded.
14. The top senior, intermediate and junior individuals will receive an award. Places second through fifth in each division will receive an award. Places 6-10 in each division will be recognized.
15. Independents may judge in order to compete for awards.
16. Each entry form must be signed by an Agriculture Science Teacher or County Extension Agent.
17. An Award will be given to the high point senior, intermediate, and junior individuals from Kleberg/Kenedy County.

ADULT HOME ECONOMICS DIVISIONS

CANDY: Six (6) pieces of candy displayed on a small paper plate, covered in a zipper bag. **NO MIXES**

COOKIES: Six (6) cookies will be displayed on a small paper plate in a zipper bag. **NO MIXES.**

CAKES: All cakes must be on a board or cardboard no more than 1 inch larger than the cake and covered in plastic wrap. **NO REFRIGERATION. NO GLASS PANS.**

MIXES PLUS: Examples: Cakes, Cookies, Candy, Breads, and Pies

SUGAR FREE DESSERTS: Place in the appropriate container for what type of item you choose.

PRESERVED FOODS: Only one item may be entered.

Examples: Pickles, relishes, jellies, preserve, jams, jerky, or sauce

QUICK BREADS: Place in a foil container with a clear lid or wrapped in clear plastic wrap.

ARTS AND CRAFTS: Examples: Creative Arts, Industrial Arts, Decorative Arts, Clothing, Embroidery, Needlepoint, Afghans, Dolls, Pillow, Recycle, Holiday and Miscellaneous

QUILTING: Class: Hand-pieced and quilted, hand-appliquéd and quilted, machine-pieced and quilted, machine-appliquéd and quilted, combination, small wall hanging, clothing, and miniature doll quilts

RECYCLED ART: Any type of art or craft that is composed of completely recycled materials. (Adhesive, thread or paint may be used to bind or enhance the art or craft)

PHOTOGRAPHY: Not larger than 8 X 10. Must be mounted, not framed (self-made mounts are acceptable.)

1. Exhibitors must be 18 or older and reside or work in Kleberg-Kenedy County, be a visiting winter Texan, or a member of the Kleberg Extension Education Association.
2. Entry Fee: See Entry Fee Schedule on page 5. All entries and fees will be processed online according to Entry Section.
3. Articles must be work of exhibitor and completed in the last year. No substitutions accepted.
4. Check in for Adult Homemaking entries will be Monday from 5:00pm-8:30pm preceding the Wednesday animal check in for the stock show (check show schedule for dates), with judging on Tuesday at 9:00am. Adult Homemaking food entries will be judged and a single serving will be displayed with its ribbon for the public viewing. Food entries not displayed will be ready for pick up Tuesday afternoon. Public viewing begins Wednesday at 6:00pm, with viewing on Thursday from 9:00am-7:00pm, and Friday 9:00am-3:00pm. KKJLS provides security and superintendents and their committee will help monitor the room, but neither the KKJLS, superintendent, or the homemaking committee will be responsible for damage or loss of project. It is imperative that each exhibitor volunteer to help monitor the room to help protect the youth and adult projects. Pick up of ALL projects will be between 3:00pm and 4:00pm on Friday.
5. Ribbons will be awarded to all entries. One Rosette in each DIVISION, unless no entry merits the award. All rosette-winning exhibits will be eligible for a \$25.00 award. Total high point winners in both the foods and the crafts division will receive the \$25.00 awards.
6. All canned foods will be displayed in STANDARD canning jars, with rings loose, lids sealed, and labeled WITHOUT exhibitor's name. After judging, opened jars may be replaced with identical sealed jars.
7. A slice of pies, cakes, or breads will be put on display with ribbon. After judging, remainder may be picked up.
8. Recipes, patterns, or description (instructions) on index card to be included with each item. This will be for judges use. Exhibitor's name should NOT be on card.

COOK-OFF

1. IBCA Rules Apply
2. Entry Fee for IBCA Categories is \$150 which includes Brisket, Chicken and Pork Ribs. Entry Fee for Jackpot Categories is \$25 per Category which includes Beans, Chef's Choice, and Fajita's.
3. For IBCA Categories all IBCA rules apply including turn in times and amount of food to be turned in so please refer to IBCA rulebook for clarification.
4. For Jackpot Categories all preparation and cooking must take place on show grounds during the event times. All entries must be cooked on a BBQ pit over a wood substance fire. The jackpot categories are allowed to be garnished, the turn in times will be noted on the entry form for the event as well as handed out at event check in. The following turn in amounts are required for Beans one 16oz cup of beans with nothing in the cup larger than a bean.

- No fillers allowed (i.e. meat, macaroni, etc...) Chef Choice will require 9 full portions/servings that must contain meat or seafood and can be wild game. Fajitas will require 9 slices equaling roughly 1 pound of meat. Containers for beans, chef's choice and fajitas will be provided.
5. Each team will be allocated a 30ft by 30ft space to set up BBQ pits, travel trailers, vehicles, tents etc...We ask that each team do their best to keep inside their allotted area. All vehicle traffic inside the cooking area must stop by 9am Saturday morning inside the cooking area.
 6. The head cook is responsible for their team and their guest please help to ensure that all behavior is appropriate during the event.
 7. The Kleberg-Kenedy County Junior Livestock Show Association its members and its sponsors are not responsible for any theft or damages.
 8. No Open Flames on the ground during the event, all fires must be contained.
 9. Providing samples to the public is appreciated.

AWARDS

Awards to be given as follows for steers, heifers, bulls, rabbits, lambs, goats, swine, poultry, Stock horse and farm shop:

1. All overall Grand and Reserve Champions to receive a buckle and award.
2. Breed/Division Champion and Reserve Breed/Division Champion (if it applies to division) receives an award(s).
3. Classes to receive ribbons places 1st-10th not to exceed 10 places.
4. Awards to be given as follows for Horse Show:
 - A. All around Junior, Intermediate, Senior and Champion Pee Wee winners to receive a buckle.
 - B. **Timed Event Champion and Performance Champion in Junior, Intermediate, and Senior divisions to receive award(s).**
 - C. Grand Champion Mare, Gelding, and Yearling Stallion and Reserve Grand Champion Mare, Gelding, and Yearling Stallion to receive award(s).
5. Awards to be given as follows for Pee Wee divisions:
 - A. Champion participant per each age group (Jr. and Sr.) to receive a buckle and award.
6. Awards to be given as follows for Queens Contest:
 - A. Overall winner in each age division (Jr, intermediate and Sr) to receive a buckle and award
 - B. Runners up to receive award(s)
7. Awards to be given as follows for Showmanship:
 - A. Each age division (Jr, intermediate and Sr) winner to receive a buckle.
8. Awards to be given as follows for Homemaking Divisions:
 - A. Grand and Reserve champion to receive a buckle and award(s).
 - B. The rest of the awards are to be given out as listed in Homemaking Section rule #8.
9. Awards to be given as follows for Livestock Judging:
 - A. High point participant per each age group (Jr., intermediate and Sr) to receive a buckle and award.

In the case where there is no buckle sponsor, no buckle will be awarded. Production or issuance of buckles or awards not listed above is a violation of the rules of KKJLS.

KLEBERG-KENEDY COUNTY JUNIOR LIVESTOCK SHOW DEDICATION PROCEDURE

The following guidelines should be used for the process of selecting, if desired, a nominee for dedication of the Kleberg-Kenedy County Junior Livestock Show (KKCJLS) in any given year. It should be noted that it is not mandatory to select someone to dedicate the show to every year but if there is a dedication it should follow these guidelines.

The President should appoint a three (3) to five (5) person committee to serve as the Show Dedication Nominating Committee. This appointment should be made after the election of officers along with any other committee appointments that are made by the president.

The Show Dedication Nominating Committee shall have the following duties and responsibilities:

1. Collect written nominations for eligible nominees from members
2. Submit eligible nominees to the board for consideration
3. Determine if the nominee meets the following requirements:

- a. The nominee must support or must have supported the KKCJLS
- b. The nominee is or was in good standing in the community

Nominations for the KKCJLS show dedication should be submitted in writing to any member of the Show Dedication Nominating Committee. The written biography of the nominee may contain past accomplishments, past support for the KKCJLS and any other information that the nominator feels will convince the Show Dedication Nominating Committee and the KKCJLS board of directors that the nominee is deserving of the dedication honor. All nominations must be turned in one hundred (100) days prior to the KKCJLS check-in date to be considered. If no nominations are received by that date there will be no show dedication for that year.

Once the written nomination biography(ies) are received by the Show Dedication Nominating Committee they are reviewed and assembled for submission to the board of directors. ALL written nomination biography(ies) will be sent to all of the board of directors within ninety (90) days prior to the show check-in date. The board of directors will convene no less than eighty (80) days prior to the show check-in for the purpose of selecting, from the written nomination biography(ies), a person to whom the show shall be dedicated. Neither nominations from the membership nor nominations from the board will be considered unless they have been submitted to the Show Dedication Nominating Committee, in writing, prior to the hundredth (100th) day before the check-in date.

The decision of the board of directors of the Kleberg-Kenedy County Junior Livestock Show association will be made from the nominees supplied by the Show Dedication Nominating Committee. The decision will be final.

COMMERCIAL EXHIBITS DIVISION

1. Set up date and time for concessionaires will be determined once show schedule has been approved.
2. All Commercial Exhibits Booths will be open for a minimum of the following hours: Wednesday 5 p.m. - 9 p.m., Thursday 10 a.m. - 9 p.m., Friday 10 am - 9 p.m., Saturday 10 am - 9 p.m. Failure to comply will result in vendor being banned from future commercial exhibits opportunities with KKJLS. All displays must be removed from the show grounds by 12 noon Sunday.
3. The Kleberg-Kenedy County Fair shall under no circumstances be liable for any loss, damage, or injury to any person, animal, article, or equipment.
4. Exhibit or concession space may not be transferred or any portion of it sub-let to another party without the consent of the Association Executive Committee.
5. The Association Executive Committee has the right to cancel the contract of any commercial exhibitor or concessionaires, if in their judgment the business or the manner of conducting same is objectionable or not as presented in the contract. The Association Executive Committee may also have all property removed from the show grounds. Any sales or giveaway item that is determined by the Association Executive Committee, to be contrary to the best interests of the youth of Kleberg-Kenedy Counties or disruptive to exhibit animals may be removed from sale or giveaway. The removal of only one of a series of items will not cause the Cancellation of the contract.
6. Nothing shall be sold, or given away which would conflict with or which is subject matter of any privilege or concession granted or sold by the Fair.
7. All improvements on said space shall be done at the expense of the exhibitor or concessionaire subject to the approval of the Association Executive Committee. Unless otherwise provided for, all improvements must be moved at the conclusion of the show at the expense of the exhibitors, or concessionaires and the space must be left in a condition equal to that at the time of occupancy.
8. No holes or other excavations shall be made on said space.
9. The Association is requiring all vendors obtain and show proof of liability insurance with a minimum coverage of \$1,000,000. (The Certificate of Insurance will need to show \$1,000,000 liability coverage, naming Kleberg Kenedy County Junior Livestock Association and City of Kingsville as additional insured covering the dates of the show.) Vendors have the option to purchase insurance coverage that is offered at a rate that will be determined each year. All vendors must submit vendor contract no later than November 1st to show office. Early contract submission is allowed for participating vendors of the current year's show. Vendors must submit payment in full at the time of contract submission. Upon acceptance, vendor will be notified that the payment will be processed. If vendor is not accepted, the payment will be returned in full. Vendors will be required to provide certificate of insurance prior to January 5th to

show office or may be faxed. THE CERTIFICATE OF INSURANCE MUST BE RECEIVED PRIOR TO JANUARY 5th TO SHOW OFFICE. If the contract is not signed and the certificated of insurance is not received prior to the above date and time the applicant's payment will be forfeited and the space will be awarded to another vendor

THE CERTIFICATE OF INSURANCE MUST BE RECEIVED PRIOR TO JANUARY 5th TO SHOW OFFICE.

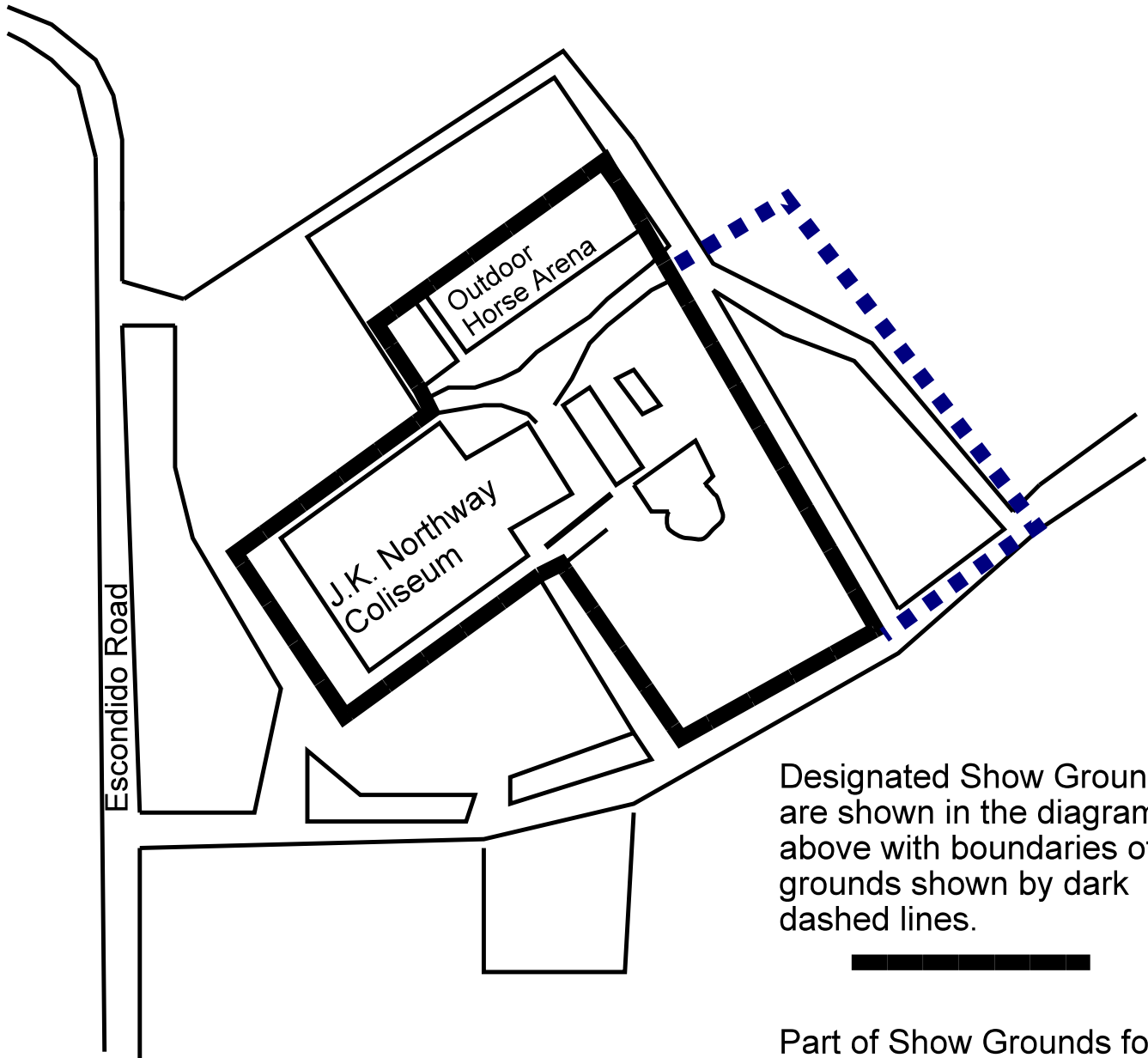

10. It will be the responsibility of the concessionaire to comply with Federal, State, County and City regulations governing their operations. The KKJLS Board of Directors will appoint a superintendent who will be responsible for the following:
 - A. Set booth rental fees based on demand and size.
 - B. Contact vendors and negotiate the price and location of their booth
 - C. Collect money for booth rentals, and
 - D. Provide a report to the association detailing the final transaction with the vendors.
 - E. Responsible for providing booth planning information to the Parks Dept.
11. All food concessions at the Livestock Show shall pay the Kleberg-Kenedy County 4-H Council 20% of their gross income.
12. Only a certain amount of specific vendors will be accepted excluding food vendors. Only merchandise listed on application will be allowed to be sold at said booth. Any unauthorized merchandise will be removed. The type of merchandise will be limited upon the discretion of the Commercial Exhibits Superintendent.
